

PARTNER & EXHIBITOR AGREEMENT



This Agreement is made this ____ day of _____, 20____, by and between the NiUG International (NiUG) and _____ (Partner/Exhibitor).

Partner/Exhibitor hereby desires to support NiUG according to the terms and conditions contained herein and in the attached Partner Prospectus. Partner/Exhibitor will receive those benefits associated with the level of sponsorship chosen by the Partner/Exhibitor and set forth in the Partner Prospectus. In consideration of those benefits, Partner/Exhibitor agrees to the following terms and conditions:

1. Partner/Exhibitor understands and agrees that the exhibit space will be assigned at the sole discretion of NiUG.
2. Partner/Exhibitor agrees to accept relocation in other exhibit space of comparable area should such relocation be deemed necessary at the discretion of NiUG.
3. Partner/Exhibitor may not breakdown exhibit early without written approval from NiUG. Any Partner/Exhibitor who violates the early breakdown policy as set forth in the Partner Prospectus will incur a \$500 penalty fee.
4. NiUG at its sole discretion will appoint the exhibit hours for the Partners/Exhibitors as set forth in the Partner Prospectus. NiUG makes no representations as to the potential attendees during this time only that said time will occur.
5. Partner/Exhibitor will be solely responsible for arranging for set up of the exhibit including but not limited to additional electrical needs above the \$50 per day allowance, audio-visual necessities, etc. with the appropriate contractor and for payment of all fees due these contractors for services rendered. Partner/Exhibitor agrees to be bound by any and all rules of the Event Facility including union rules.
6. A Partner/Exhibitor may cancel if marketing of your company as a partner or exhibitor has not yet begun. Payment, minus a 25% administrative fee, will be refunded upon a written request for cancellation. No refund shall be made to any exhibitor who cancels the contracted booth after conference marketing has begun. No shows are treated as such and will not receive a refund.
7. Partner/Exhibitor assumes entire responsibility and hereby agrees to protect, indemnify, and defend, and hold harmless NiUG, and its respective employees, directors and agents against all claims, losses, and damages to persons or property, governmental charges or fines, and attorney fees arising out of, or caused by Partner/Exhibitor's installation, removal, maintenance, occupancy, or use of the exhibit area or a part thereof.
8. Partner/Exhibitor hereby represents that it maintain sufficient liability insurance that covers all potential liability during the exhibit. In addition, Partner/Exhibitor acknowledges that NiUG does not maintain insurance covering Partner/Exhibitor's property and that it is the sole responsibility of the Partner/Exhibitor to obtain insurance covering such losses.
