What is the difference between an Organizational, an Associate, & a Vendor Member?

Organizational Members are user-companies, including associations, association management companies, philanthropic, religious, and community-based organizations, and any other entity that has purchased iMIS for the sole purpose of maintaining their business. Associate Members are solution providers and consultants who are authorized through ASI as an AiSP or AiC. Vendor members are vendor companies who have a product that integrates and/or enhances iMIS. In addition to the dues difference, Associate and Vendor Members are not eligible for Executive Committee Board positions but can participate on other NiUG Committees and serve as Chapter Representatives.
